Why Growth?

- Population growth rate of **1.3%** lagging Provincial average of **5.8%** (Census 2016-2021)
- Second slowest growth rate in Canada
- Over the past 10 years Thunder Bay's tax base has grown by 0.63%, significantly lagging inflation of 31.7% (Based on CPI).
- Cities purchasing power has **diminished significantly** every year over the last ten years forcing tax/rate increases above inflation
